Additional information

Why was I selected?

Your name was selected at random, like that of several thousand other parents of children under the age of 18, as part of the *Québec Parenting Study*.

We obtained the personal information needed for the study, including your contact information, from the Régie de l'assurance maladie du Québec (RAMQ), under an agreement approved by the Commission d'accès à l'information in accordance with the *Act respecting Access to documents held by public bodies and the Protection of personal information*.

Do I have to participate in this study?

Your participation in the study is voluntary but important, since it will allow the Ministère de la Famille to draw a portrait of the experiences of Québec parents in order to adapt the services offered to families.

Quality monitoring

For quality and training purposes, telephone conversations with Statistique Québec agents are recorded. If you do not want your conversation to be recorded, simply notify the agent at the beginning of the call.

Confidentiality and data transmission

The study is conducted in accordance with the *Act respecting the Institut de la statistique du Québec*. Statistique Québec has entered into an agreement with the Ministère de la Famille, to whom the information collected will be sent, with the exception of your name, address, and telephone number. All of your information will be kept confidential and will only be used for statistical purposes.

Ethics

The study was reviewed by the ethics committee appointed by Statistique Québec. The ethics committee is responsible for safeguarding the respect, dignity and integrity of those participating or included in the study.
